
I enclose signed acknowledgment of the scheduled oral argument in this case. I apologize of not having returned this sooner. I have been out of town, and read the notice just today.

This case involves an appeal by Kellett and a cross appeal by Turner. There was considerable confusion on our (and Mr. Gaddy's) part regarding the format of briefs; and we learned that entirely separate appellate, response and reply briefs are required in each case where there is both an appeal and a cross appeal.

I would like to avoid similar confusion on the oral arguments. Will the appeal and the cross appeal be argued separately, or will they be combined for oral argument? If not, will the Appellant-Respondent (Kellett) argue against Turner's cross appeal before Turner argues? And will the Respondent-Appellant (Turner) be permitted to reply to Kellett's argument opposing the cross appeal?

These may be rudimentary questions. But in sixty years of practice, this is the first case I have had involving a cross appeal; and I want to be sure that we - and Mr. Gaddy - plan our arguments efficiently.
