DEAR COURT OF APPEALS,

I RESPECTFULLY REQUEST A STAY OF THE DEADLINE TO PREPARE A REPLY TO MR. DUDEK'S ANDERS BRIEF, FOR THE FOLLOWING REASONS;

1) I DO NOT HAVE A COMPLETE RECORD TO WORK FROM; AS STATED IN MY OCTOBER 6, 2018 LETTER TO MR. DUDEK (COPY ATTACHED, EXHIBIT A) THE MAY 15, 2018 PRE-TRIAL HEARING TRANSCRIPT IS MISSING, THE FIRST PART OF VOIR DIRE IS MISSING AND I NEED THE ACS II RECORDINGS BECAUSE I BELIEVE THE TRIAL TRANSCRIPT IS INCOMPLETE.

2) SCDC Policy states at GA-01.03 UNDER LAW LIBRARY HOURS THAT THE LIBRARY IS TO BE OPEN NO LESS THAN 37.5 HOURS. HOWEVER, THE REALITY IS THAT THE LIBRARY IS ONLY OPEN 11 HOURS AT BEST WITHOUT COUNTING LOCK-DOWNS, SHORT STAFFING ISSUES, ETC. SEE ATTACHED COPIES OF LAW LIBRARY SIGN-UP SHEETS, 2 PAGES (EXHIBITS - B)

AS OF THIS WRITING I HAVE HAD LESS THAN 2 HOURS OF MEANINGFUL ACCESS TO WEST LAW, DESPITE MY BEST EFFORTS.

3) IT IS MY UNDERSTANDING THAT AT THE LEAST THERE ARE 3 ISSUES STILL "IN PLAY" AT THIS TIME FROM "THE AMENDED MOTION TO RECONSIDER" FOR WHICH THIS HONORABLE COURT DENIED THE STATE'S MOTION TO DISMISS ON SEPTEMBER 20, 2017. PLEASE SEE ORDER

4) THE ACS II RECORDINGS SHOULD SHOW THAT JUDGE HAYES STATED "MR. HOLCOMB, YOU HAVE MORE APPEALS THAN THE WHITEHOUSE CHRISTMAS TREE HAS ORNAMENTS." OR SOMETHING TO THAT EFFECT.

I REQUEST AN ORDER INSTRUCTING APPELLATE DEFENSE SUPPLY ME WITH THE COMPLETE TRANSCRIPTS, ACS II RECORDINGS, AND THE EXHIBITS. AND AN ORDER THAT SCDC PROVIDE ME WITH NO LESS THAN 20 HOURS A WEEK OF COMPUTER LEGAL RESEARCH ACCESS TO PREPARE A PROPER RESPONSE IN ACCORDANCE TO ANDERS V. 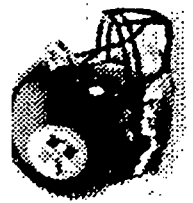
