COMES NOW Lisa Fisher, Appellant in the above appeal files objection to the purported “factual” assertions in *Respondent Bessie Huckabee’s Reply to Appellant Lisa Fisher’s Opposition to Motion for Costs* (received November 5, 2018).

Respondent fails to request judicial notice of the dates and factual assertions in her reply. Appellant Objects to all references to “factual statements” in said document which is unsworn. As such, said document should be ignored.

The main purpose of these objections by Appellant is to ensure that the continued manipulation and lies by Respondent do not go unnoticed, where she claims that:

“Appellant’s suggestion that this Court acted with impropriety by informing the Respondent that because the appeal was dismissed, she would need to file a separate pleading in order to pursue sanctions further illustrates the frivolous actions of Appellant.” (Reply, p. 2, fn. 1)

Appellant did not suggest that this Court acted with “impropriety”, she specifically stated that “the accommodations [given] to Respondents create *an appearance* of favoritism.” (Emphasis added) This case has been fraught with “appearance[s] of favoritism” and accommodations, as noted by the grant of \$5,000.00 without legal authority.¹ Appellant has a right to make this legitimate argument of an *appearance* of favoritism, however Respondent does not have a right to manipulate this legitimate argument into a claim that Appellant accused the court of acting improperly.

Respondent has no shame that she obtained a judgement by committing a fraud on the court and against an innocent woman *when she knows that the woman was only at Alice Shaw Baker’s property because of Appellant*, requiring payment of \$5,000.00 when there is no legal

authority for such payment, seeking attorney fees when there is no final determination in the underlying case—no shame, however she tries to shame Appellant before this court by claiming that she accused the court of illegal conduct. Appellant did not.

For all these reasons, the “factual assertions” by Respondent should not be considered and should be stricken as hearsay, lacking in foundation, argumentative, and not relevant.


