MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT
OF CERTIORARI AND APPENDIX

Counsel for Timothy Lamar Townsend respectfully requests an extension of thirty (30) days in which to file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

Counsel filed the Petition for Writ of Certiorari and accompanying appendix in the case of Dwayne Lee Rudd v. The State with this Court on September 21, 2018. Counsel filed the Petition for Writ of Certiorari and accompanying appendix in the case of Michael Browning v. The State with this Court on September 21, 2018. Counsel filed the Petition for Writ of Certiorari and accompanying appendix in the case of Shonathan M. Jeter v. The State with this Court on September 5, 2018.


4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office has been informed of this request and consented in advance on Friday, November 9, 2018 to this extension request.


WHEREFORE, the undersigned counsel would respectfully request a thirty day extension, in which to file the Petition for Writ of Certiorari and Appendix in this case based




