Counsel filed the brief of petitioner in the case of William McCladdie v. State in the Court of Appeals on October 4, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Richard Todd Culberson v. State in the Supreme Court on October 1, 2018. Counsel attended the 2018 Annual Public Defender Conference from September 23 through September 26, 2018 in Myrtle Beach, S.C.


3. This request is made in good faith, and not for purposes of delay.

4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


