Appellant presents this Motion to the Court to file fewer copies in order to reduce the total number of pages in Appellant's record on appeal by 100 pages, by allowing the photographic reduction on pages 229-263. From the Court's letter of November 9, 2018, "pursuant to Rule 267(c), SCARC, the photographic reduction of the portion of the transcript printed on pages 229-263 of the record on appeal is not allowed."

Appellant's deposition on pages 229-263 as currently presented in Appellant's record on appeal is a total of 35 pages. If Appellant is required to correct the pages to an 8 ½"x 11" format, the pages would increase to 135. Corrected, the total copies from 14 bound and one unbound to the Court, one to opposing attorney, and one for Appellant would total 6,350 pages, an increase of 1,700 copies.

Appellant respectfully asks the Court to grant this motion to file fewer copies of his deposition on pages 229-263 as presented in his record on appeal.

In the alternative, should the Court deny Appellant's Motion to reduce the number of copies in the record on appeal, Appellant requests an extension of time, 20 days from the date the Court denies Appellant's Motion, to correct pages 229-263 of his record on appeal and add the required 1,700 copies.


