NOTICE OF APPEAL

Arnold Jr., and Dazarhea Parson appeals the order of the Honorable Thomas A. Russo dated October 25, 2018. Appellants received electronically written notice of entry of this order on October 25, 2018. On June 4, 2018 Appellants filed in the Marion County Clerk of Courts Office a Motion for Relief from Void Judgment 60(b)(4); and Challenged the Jurisdiction. On July 24, 2018 Appellants filed Affidavit of Truth in the Marion County Circuit Court. On

September 24, 2018 Appellants filed a Request for findings of facts and conclusion of law pursuant to South Carolina Rules of Civil Procedure Rule 52(a). On October 1, 2018 Judge Russo entered an order denying Appellants 60(b)(4) Motion for Relief from Void Judgment; and Challenge of Jurisdiction. On October 10, 2018 Appellants timely filed Motion/Alter and/or Amend final order pursuant to South Carolina Rules of Civil Procedure Rule 59(e). On October 25, 2018 Judge Russo entered an order denying Appellants Motion to Alter or Amend Judgment. Appellants further states that the Honorable Thomas A. Russo abused his discretion in entering said order including but not limited to the overlooking and misapprehending state and federal law, denial of due process, and violations of constitutional and statutory law. The judge further abused his discretion by failing to enter a ruling on all issues brought before the court for determination.
