
1. The petition for writ of certiorari and accompanying appendix in this case are due to be served and filed today.
2. Counsel will file the petition for rehearing in the case of The State v. Dajlia Torbit with the Court of Appeals today, November 21, 2018. Counsel will file the petition for writ of certiorari and appendix in the case of Efrain Rivera v. State with this Court today, November 20,

2018. Counsel filed the petition for writ of certiorari and appendix in the case of Sasha Thomas v. State with this Court on November 20, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Alexander Matthews with the Court of Appeals on November 16, 2018. Counsel filed the petition for writ of certiorari and appendix in the case of Anthony Wilson v. State with this Court on November 14, 2018. Counsel had an oral argument in The State v. Ontario Makins before the Court of Appeals on November 7, 2018. Counsel filed the petition for writ of certiorari to the Court of Appeals and accompanying appendix in Samuel Alexander v. The State with this Court on October 22, 2018. Counsel filed the petition for writ of certiorari and appendix in the case of Bill Booker v. State with this Court on October 19, 2018. Counsel filed the petition for writ of certiorari and appendix in the case of Boyd Rowe v. State with this Court on October 15, 2018. 


