Per your request, Ken Murphy was one of the trial counsel in this case. He has a conflict on March 5 and 6; he's in trial in New Jersey. Trial is scheduled to start on February 19, and to last four weeks. The case is Saw v. McNeil Consumer & Specialty Pharmaceuticals, No. ESX-L-1666-05, Superior Court of Essex County, New Jersey. Please note that Ken Murphy was one of the trial lawyers in this matter but is NOT listed as counsel in the appeal. However, he was trial counsel and would like to assist in preparation for this matter near the date of the argument.

Steve Pugh *IS* listed as one of the attorneys on the appeal. He was also one of the trial attorneys in this matter. He has a trial scheduled to begin in Charleston on March 11, 2013 and thus would be unavailable to assist much with preparation near March 5 or 6, he informs.
