MOTION FOR AN EXTENSION OF TIME

number of extensions previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.



Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Chadwick Cribb v. The State with the Supreme Court on November 9, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Quadrik Willis with this Court on November 7, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Michael Wilson v. The State with the Supreme Court on November 5, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Tyrone Robinson with this Court on November 2, 2018. Counsel filed the brief of petitioner in the case of Antrell Rashawn Felder v. The State with the Supreme Court on October 24, 2018. Counsel filed the initial brief of respondent and designation of matter in the case of The State v. Bruce Stanley Jones with this Court on October 19, 2018. Counsel had an oral argument in the case of The State v. Jimmy Turner before the Supreme Court on October 17, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Kenneth Collins with this Court on October 9, 2018. Counsel had an oral argument in the case of The State v. Robin Herndon with this Court on October 9, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Leon Barksdale with this Court on October 8, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Travis Napoleon Davis v. The State with the Supreme Court on October 8, 2018.

4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions-first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

WHEREFORE, the undersigned counsel would respectfully request a **fourth and final thirty (30) day extension** until **December 27, 2018**, in which to file the initial brief of appellant and designation of matter in this case based upon the above exigent circumstances. Counsel requests that time limits for filing the brief be held in abeyance pending a ruling on this motion.




