

Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Leon Barksdale with the Court of Appeals on October 8, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Travis Napoleon Davis v. The State with the Supreme Court on October 8, 2018. Counsel attended the state Public Defender Convention in Myrtle Beach, South Carolina on September 24, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Keiron Coleman v. The State with the Supreme Court on September 21, 2018. Counsel had an oral argument in the case of The State v. Corey J. Williams with the Supreme Court on September 19, 2018. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jose Cabarruvias v. The State with the Supreme Court on September 17, 2018.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


4. As indicated by the consent below, counsel for the state graciously consents to or does not oppose this request.


