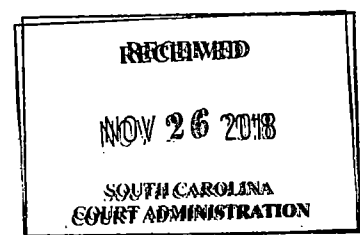

The last legal mail I received from you was the court order for a writ of certiorari being granted and it says the parties shall proceed to serve and file the appendix and briefs as provided by Rule 243 SCACR. If I'm not mistaken this part has already happened because I've been had my appendix and all of my briefs has been filed on my behalf by Ms. Hackett and to my knowledge they all have been granted and filed. Will you please check my case to see if I'm correct about this. Ms Hackett sent me 2 copy of the same order you sent me and

She also stated that the petition for a writ of certiorari would be filed by October 24 and I'd like to ask you the same as I asked Ms. Hackett was it filed? Can you please explain this to me so I can understand what exactly does any of this has to do with me going home to my family? Put yourself in my shoes for a few minutes I've been arrested without probable cause and prosecuted " " " Convicted and sent to prison for the last 4 years with no evidence or anything and then the public defender saw that I would get this case overturned on appeal so what does he do he doesn't file my direct appeal until 30 days later so no direct appeal on purpose and then to make the matters worse I had went ahead and filed my PCR in Oct. 2015 and McMillen not knowing that I had filed it sent me another PCR APP

lication that he had filled ^{out} claiming
he was ineffective as my counsel
and he needed for me to get it
notarized and sent to AG office
but I had already sent mine in
and gotten it back and that's
when Judge EARLY stepped in to
grant me a belated direct but
dismissed my PCR application with
prejudice and he knew he couldn't
be my Criminal Judge as well as
my PCR Judge. Conflict of Interest
he should have recused himself.

They all was trying to cover up
this miscarriage of Justice, malicious
prosecution, vindictive prosecution,
False Imprisonment, Kidnapping, equal
protection violation, Due Process violation
Cruel & unusual punishment, Legal malprac
tice, criminal conspiracy, Judicial

they did this to me I didn't take

for something everybody who's
important such as the Supreme
