BRIEF OF SOUTH CAROLINA ASSOCIATION OF COUNTIES**


**TO: THE HONORABLE JUDGES OF THE SOUTH CAROLINA COURT OF
APPEALS:**

Respondents City of Georgetown and the South Carolina Department of Transportation (SCDOT) respectfully move this Court for an Order granting them an extension of twelve (12) days until December 15, 2018, in order to file Respondents' Reply to the *Amicus Curiae* Brief of the South Carolina Association of Counties.

The current deadline is December 3, 2018. While the Reply Brief usually would not be so onerous as to require an extension of time, here, counsel for the Respondents

was afforded less than one week to respond to said *Amicus Curiae* Brief. 
