
**COUNT ONE - MURDER**

That the Defendant, Roy Gene (aka Danny) Sutherland, III, did in Spartanburg County on or about January 6, 2018, feloniously, willfully, and with malice aforethought, kill one Lanham Joseph Wood, by beating him about the head and/or stabbing him with a knife, and the victim died as a proximate result thereof, all in violation of Section 16-3-0010, 0020, Code of Laws of South Carolina, (1976, as amended).

**COUNT TWO - POSSESSION OF FIREARM DURING COMMISSION  
OF A VIOLENT CRIME**

That the Defendant, Roy Gene (aka Danny) Sutherland, III, did in Spartanburg County on or about January 6, 2018, visibly display a knife during the commission or attempted commission of a violent crime, to-wit: Murder, in violation of Code §16-23-490, *CODE OF LAWS OF SOUTH CAROLINA*, (1976), as amended
