At a Court of General Sessions, convened on JUNE 7, 2018 the Grand Jurors of FLORENCE County present upon their oath:

**COUNT ONE- DISTRIBUTION OF COCAINE BASE**

That **Adrian Patrokele Nero** did in Florence County, on or about August 25, 2017, distribute, dispense or deliver, or did aid, abet, attempt or conspire to distribute, dispense or deliver to a Confidential Informant of the Lake City Police Department, a quantity of Cocaine Base, a controlled substance under provisions of Section 44-53-110, et. seq., Code of Laws of South Carolina, 1976, as amended, such distribution not having been authorized by law, and being in violation of Section 44-53-375(B)(3), S. C. Code of Laws, 1976, as amended.

**COUNT TWO- DISTRIBUTION OF COCAINE BASE WITHIN PROXIMITY OF A SCHOOL**

That **Adrian Patrokele Nero** did in Florence County on or about August 25, 2017, unlawfully distribute to a Confidential Informant of the Lake City Police Department, a quantity of Cocaine Base, a controlled substance under provisions of Section 44-53-110, et. seq., S. C. Code of Laws, 1976, as amended, while in, on, or within a one-half mile radius of the grounds of a public or private school, college or university, a public playground or park, or a public vocational or trade school or technical education center, to wit: The Alternative Center for Education and Early Childhood Development, in violation of Section 44-53-445(B)(2), S. C. Code of Laws, 1976, as amended.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
