MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel for Tyrone Deshawn Davis respectfully requests a **final thirty (30) day extension, until January 7, 2019**, in which to file the petition for writ of certiorari and appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix are due to be filed with the Court today. The Court has granted counsel two previous extensions.

number of extensions previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.



Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Nelson Sentelle Cook with the Court of Appeals on October 31, 2018. Counsel filed the Petition for Writ of Certiorari with the appendix in the case of Larry James Tyler v. The State with the Court of Appeals on October 31, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Kevin McDaniels with the Court of Appeals on October 23, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Rusty Antron Jones with the Court of Appeals on October 17, 2018. On September 24 – 26, 2018, counsel attended the Public Defender Convention in Myrtle Beach, South Carolina.

5. Counsel for the Attorney General's office consents to this request as shown by signature below.




