
Counsel also moves this Court to accept this request out of time. The petition and appendix were due on December 3, 2018, and counsel overlooked making this request.



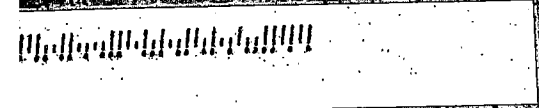
