
**MOTION FOR ORAL ARGUMENT**

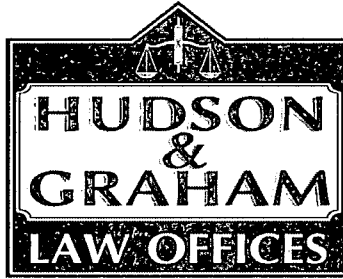
