Dear Mr. Shearouse:

On September 20, 2018, Jason A. West, filed and served a notice of appeal following the denial of his application for post-conviction relief (PCR). An order of dismissal accompanied the filing. On October 5, 2018, our office requested the transcript from the PCR hearing that occurred on May 21, 2018. On November 21, 2018, we received the transcript. On December 10, 2018, I was assigned to represent Mr. West.

Upon my review of the file, I realized that Mr. West's PCR hearing occurred over two days: May 21, 2018, and July 26, 2018. Although these dates appeared in the order of dismissal, the second date was overlooked when we ordered the transcript initially. Having realized this error, we are ordering the transcript from the portion of the PCR hearing that occurred on July 26, 2018. A copy of the request to the court reporter is enclosed.

The petition for writ of certiorari in the case are due to be served and filed on January 21, 2019. I respectfully request that the time limits be held in abeyance pending receipt of a corrected transcript. 
