PETITION FOR EXTENSION





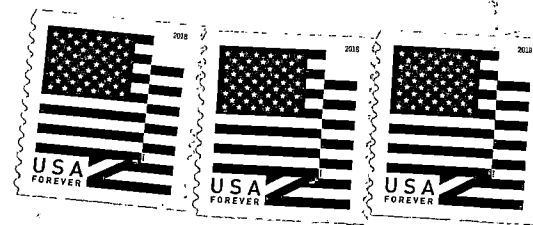
