MOTION FOR AN EXTENSION

On November 30, 2018, this Court issued its Order granting the Appellants' and the Respondent's petitions for rehearing. In light of the Supreme Court's recent ruling in *The Callawassie Island Members Club, Inc. v. Dennis*, the Court gave the parties permission to file supplemental briefs. This Court's Order allows the parties 30 days in which to serve and file any such supplemental briefs, which would make those briefs due on December 31, 2018.


The Appellants respectfully request that they would be given a 30-day extension until January 30, 2019, in which to file their supplemental brief in this appeal. The grounds for this motion include (1) the complexity of the issues on appeal, (2) the

additional analysis that is required in light of the *Dennis* ruling, (3) numerous other briefing deadlines for undersigned counsel during the time-period, including briefs due to the Fourth Circuit Court of Appeals and to the United States District Court, District of South Carolina, as well as (4) the time constraints presented by the upcoming holiday season.

Appellants have consulted with counsel for the Respondent regarding this extension, but at this writing have not received a response regarding whether Respondent consents or not. Appellants have no objection to the extension applying to all parties to this appeal.

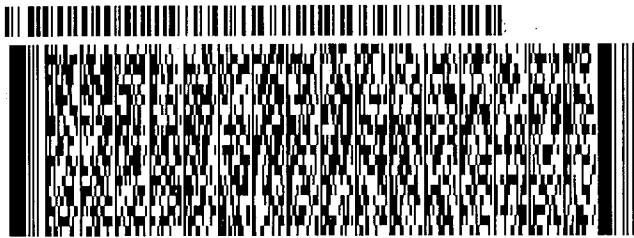

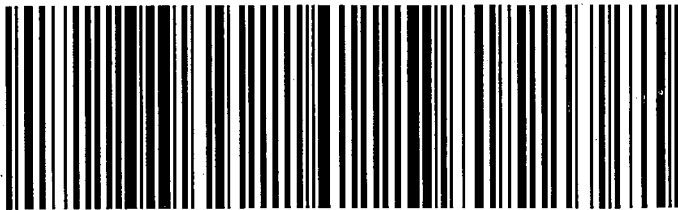
