MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel for Timothy L. Townsend respectfully requests a **final thirty (30) day extension, until January 14, 2019**, in which to file the petition for writ of certiorari and appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix are due to be filed with the Court today. The Court has granted counsel two previous extensions.
2. Counsel for Timothy L. Townsend respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the


number of extensions previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.

Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Joseph Goodrich with the Court of Appeals on November 21, 2018. Counsel filed the Petition for Writ of Certiorari and the accompanying appendix in the case of Timothy Johnson v. The State with this Court on November 19, 2018. Counsel filed the Petition for Writ of Certiorari and accompanying appendix in the case of Dominique J. Shumate v. The State with this Court on November 14, 2018. Counsel filed the Petition for Writ of Certiorari and accompanying appendix in the case of Edward L. Morris v. The State with this Court on November 9, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Nelson Sentelle Cook with the Court of Appeals on October 31, 2018. Counsel filed the Petition for Writ of Certiorari with the appendix in the case of Larry James Tyler v. The State with the Court of Appeals on October 31, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Kevin McDaniels with the Court of Appeals on October 23, 2018. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Rusty Antron Jones with the Court of Appeals on October 17, 2018. On September 24 – 26, 2018, counsel attended the Public Defender Convention in Myrtle Beach, South Carolina.


4. Counsel makes this request in good faith and not for purpose of delay.
