

I am aware of the Court's Order regarding the costs for copies, etc. I seek to know the exact amount for these requests, if any.

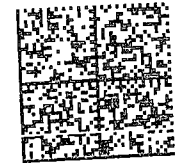
