I'm writing to inform you that I have recieved word back about the transcript for the forfeiture hearing, I have included a copy ~~for~~^{of} the letter here with this one. Now the transcript will be \$4.25 a page, which is 20 pages long. The cost will be \$85.00. I Filed my appeal as a poor person. Being that I have been in detention for 17 months going on 18 month (1 year and a half) with out a job, "I'm not able to pay \$85.00". I still haven't been able to keep up with all my legal requests made by these others in my criminal case (Sheriff's Office, transcripts of bond hearing, pens to write people back, paper to write/send out, postage stamps, preliminary hearing transcript, etc.,). As I said before I have no legal assistance, nor access to legal information to help me with my case. Now I need to know what's next/the next step. I recieve the letter from Ms. Jenkins here at the detention center on 12-9-18 which was on a ~~the~~ Sunday. Thank you for your time and concern. I will send this letter off on the 11th day of December due to getting postage and a copy made (which the copp will put me another 10¢ in the red). Thank You.
