
To the Honorable Clerk of Court:

*Cali Alyson Emory, individually and in a representative capacity for all others similarly situated v. THAG, LLC, d/b/a Myrtle Beach Mitsubishi*, Op. No. 2018-UP-083 (S.C.Ct.App. filed February 14, 2018), cert. denied October 18, 2018.<sup>2</sup>

*Emory* affirmed a trial court order requiring bilateral arbitration where, as here, the arbitration clause contained textual references suggesting bilateral arbitration, rather than class arbitration, was required. This citation is relevant to sections I and II and portions of Section III of Appellant's Brief.

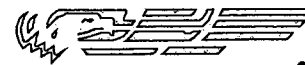
