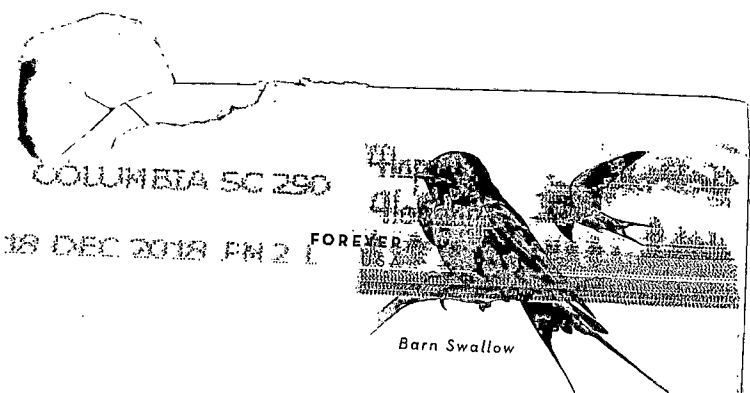
I didn't violate my bond and flee then and won't flee if granted bond now.

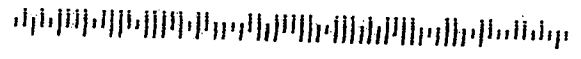
