MOTION FOR EXTENSION OF TIME TO FILE OPENING BRIEF

Appellants South Carolina Coastal Conservation League (“CCL”) and Southern Alliance for Clean Energy (“SACE) respectfully move this Court for an extension of time to file their Initial Opening Brief. In support of this Motion, CCL and SACE state as follows:


1. CCL and SACE filed an Amended Notice of Appeal on November 27, 2018.
2. The current deadline for CCL and SACE’s Initial Opening Brief is December 27, 2018.
3. Due to time constraints for personal and work obligations conflicting with CCL and

SACE's current deadline, counsel for CCL and SACE respectfully request an extension of time of fifteen (15) days to file their Initial Opening Brief and a corresponding extension for Respondent and Reply Briefs.


4. If the Court grants this request, Counsel for CCL and SACE calculate that their new deadline for filing will be Friday, January 11, 2019.
5. CCL and SACE have consented to a request from counsel for South Carolina Electric and Gas Company to move to consolidate CCL and SACE's Appeal with Appellate Case No. 2018-002117. We understand that the motion to consolidate will be filed imminently. An extension in the above-captioned case would provide the Court more time to consider and act on the consolidation request.
6. Counsel for CCL and SACE have consulted with counsel for Respondents South Carolina Electric and Gas Company, South Carolina Solar Business Alliance, LLC, Southern Current, LLC, South Carolina Office of Regulatory Staff, and South Carolina Energy Users Committee, none of whom oppose this request. Counsel for CMC Steel South Carolina has advised that it takes no position on the motion.

Accordingly, CCL and SACE respectfully request that this Court grant this Motion and extend the time for CCL and SACE to file their Initial Opening Brief until Friday, January 11, 2019.


