

Apologies to the Appellate Court for the late filing.

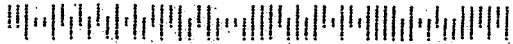
