REPLY IN SUPPORT OF MOTION TO DISMISS APPEAL

NOW COMES The State and briefly replies to the appellant’s opposition to the Motion to Dismiss. Mr. Singletary has made no valid argument as to why this appeal should not be dismissed. He has claimed that he does not have the entire file from his attorney, but has ignored the undersigned as a source for documentation. Counsel for the State has copies of every document that was filed with any attachments that were served. The undersigned is not aware of what is or is not in the file for appellant’s former attorney, but asserts that if counsel did not have copies of the documents, he could not have prepared the record on appeal either.

The attorney for the Appellant was suspended from practice in August. It has been four months now since the suspension. The appellant was given an extra month and then received two

extensions. When the November deadline came and went, Appellant made no attempt to either file the record on appeal or ask for another extension. No action was taken by Appellant until the Motion to Dismiss was filed and the court set a ten (10) day deadline for Appellant to file a proof of timely service. That deadline expired on December 17, 2018 and no proof of service has been filed, nor has any record on appeal been filed or served. For all of these reasons, this appeal should be dismissed.



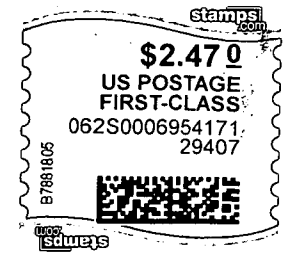
