MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel for Richard Burton Beekman respectfully requests a **final thirty (30) day extension, until January 28, 2019**, in which to file the petition for writ of certiorari and appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix are due to be filed with the Court today. The Court has granted counsel two previous extensions.

2. Counsel for Richard Burton Beekman respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

Counsel filed the Johnson petition and accompanying appendix in the case of David Lorance Adams in the Supreme Court on November 5, 2018. Counsel filed the *pro se* petition on behalf of petitioner in the case of Alonzo Columbus Jeter v. State in the Supreme Court on November 2, 2018, pursuant to the Supreme Court Order dated September 21, 2018.

4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office consents to this request as shown by signature below.




