

Dear Disciplinary Counsel:

I would like to file a formal complaint against Indigent Defense and Wanda Carter. I have been requesting a copy of 2014-GS-23-817 7 & 79 complete case file and copies of the ACS II recordings since as early as July 2017 all to no avail. This case is pending in the Appeals Court as Case# 2017-1659. Indigent Defense counsel Robert Pachak filed an Anders brief prior to retiring. Mr. Pachak filed this brief without a complete record to review. The file at the time of filing of the Anders brief lacked a transcript of the pre-trial hearing which contains issues subject to review for ~~app~~ appeal.

Since receiving the Anders brief in early October 2018 I made numerous efforts to obtain a copy of the complete file and copy of the ACS II recordings by talking and writing to Wanda Carter. I have yet to receive the copies as requested. In fact, the Appeals Court granted me an extention until December 10, 2018 in which to perfect my part in the Anders brief procedure. It is my position that a complete record is needed from which to work and Ms. Carter and Mr. Pachak's actions of indolence amount to the lowest standards of professional misconduct possible. How hard is it to ask a paralegal to make a copy of a file and mail it?

As I remain, Indomitable.

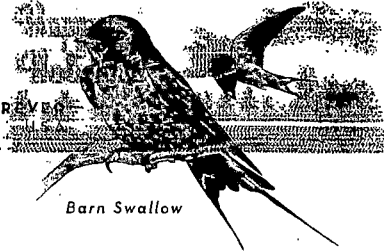
