
Pursuant to RULE 264




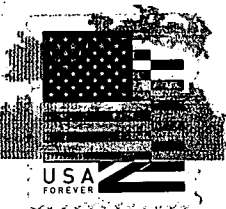
