

TO: THE HONORABLE JUDGES OF THE SOUTH CAROLINA COURT OF APPEALS:

COMES NOW the Appellant, Five Thousand Forest, LLC ("Five Thousand"), pursuant to Rule 240 of the South Carolina Appellate Court Rules, and respectfully requests this Court of Appeals to grant him a 60 Day extension of time in which to file the *Initial Brief of the Appellant*. 
