Hon. Ms. Allen,

I received your December 28, 2018 letter TODAY (December 31, 2018). This can be verified by the KCI legal documents (Mail Rec'd).

In said letter, you noted deficiencies under SC, Appellate Court Rules (SCACR) in my filing of the notice of appeal in the above-referenced case and directed that the "deficiency must be corrected within ten (10) days of the date of" your letter.

Having received your letter on that tenth (10th) day, that is now an impossible task.

with regard to said deficiencies:

- the "... order(s) and/or judgement(s) challenged on appeal..." were in the envelope that I originally mailed from SCDC, was charged for postage, but NEVER arrived at its destination;
- I can/will correct the notice of appeal to include a statement of when I received notice of entry of the order and judgement from which this appeal is taken"; and
- in my haste to get the second (2nd) notice of appeal out, I failed to enclose the documents for indigent / IN FORMA PAUPERIS filing. Again, the originals were in the original envelope. I will send another set.

Though I am sending this correspondence out immediately to make you aware of the situation created with receipt of today's mail, I am respectfully requesting ten (10) days to get these deficiencies corrected and mailed.

I am not sure how long it will take to get another copy of the ORDER from the Administrative Law Court, but I will make every attempt to get this to your office as quickly as possible.

My only request is that you consider that this entire problem has been created from my mailing a legal document through the Kirkland C.I. mailroom.

It took ten(10) days for me to receive the letter from you.

I greatly appreciate your considerations and understanding in this matter.

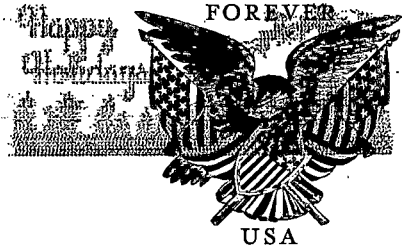
