
1. Plaintiff's Motion to Amend Complaint filed June 4, 2018



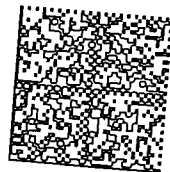
