To Judge,

My name is David Green (ID # 300923-0355). I'm still being here at Greenville County Detention Center. I've been here for going on 18 month now (from 7-11-17 to current date). I finally got answer back from the court report that was over my Forfeiture case in Greenville Co. Courthouse (case # 2017CP2305529). In front of Judge Alex Kinlaw. I now have a case in your court (Appellate case # 2018-001462) in which due to me being detained is some times hard for me to forfull time limits and fees that stem from this appeal. I filed under motion to proceed in forma pauperis, which was granted to me on October 25, 2018. I got a letter back from court reporter name is Hollie M. Jenkins (Circuit Court Reporter of Greenville Co.). Address is P.O. Box 16506 Greenville, S.C. 29606. She told me that the cost for a 20 page transcript would be \$85.00 (letter dated on December 3, 2018). I advised your appeal court that I had recieved the court reporter's letter and the cost of the transcript. On a letter wrote to me (dated December 18, 2018) I was given 15 days from the date of the letter (12-18-18) to show proof of satisfactory payment. I wrote Ms. Jenkins in order to see if the forma pauperis also covered the cost of the transcript and I had my mother E-mail her about it also. Do to the holidays Christmas and ~~Year~~ New Years Ms. Jenkins has been out of office until the second (2nd) of this month and wasn't in on the third (3rd) of this month of January. Do to the holiday(s) schedule at this detention center I could not get stamped envelope to send this letter off until now (this date 1-4-18). Also do to the holidays waiting for a response from Ms. Jenkins, Ms. Kitchings (was call by mother also "Ms. Tonja Fluthe"), this /me being in detention (with no real law library), i find

it extremely hard to get these done on time limits of some times 7 days and this time 15 days during a/the holiday seasons. Mainly coming up with \$85.00 to pay for transcripts when I have 84 in my account. Haven work since July of 2017 due to being detained this long time. I'm asking for a continuance on the 15 days to come up with the transcript which once sent to me I have to pay for copies (10¢ a page) and all so send (mailing fees) to mail them to your court. I will (God) will make away for this to happen some way.

I was wronged and also my mother was to with the Judge Alex Kinlaw decision in the case to start. It's a clear case of 44-53-530 (4)(A) provides a innocent owner property shall not be forfeited. No evidence that prior knowlege the owner knew any thing about drug being transported in there property case should be quashed and remanded (case of S.C. Law Enforcement Division v. Michael and Lance). Also as the truck being evidence in a criminal case (which in over a year none of the lawyers who was suppose to had filed to the paperwork to examine the evidence (truck) as for the truthfulness of the Deputy's statements (more than one (1) or ~~two~~ two (2) statements). I have Filed ineffectiveness of counsel on the lawyer(s). This truck holds a big key to the defence of my case. It's also why it took only a year and 8 day for this forfeiture hearing, but took a year and 48 day to get a indictment. I believe (truly) that this justice system is unfair to defendants. Solicitor Jonathan M. Gregory took a total of 163 days to amend his motion 2 times but when I file a motion in U.S District court I only got 14 days to amend (from 12-27-18 to 1-10-19). And I only got one time to get it right or my motion will be dismissed but he got 2 times, That's not fair and equal protection of the law. One standard for judicial prosecutor and another for defendants who are already down (deter^ained) with out the same access afford to them.

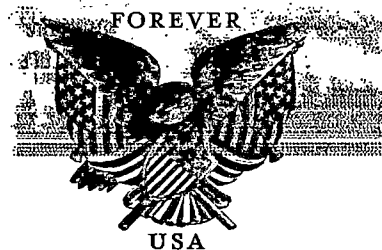
