**JOINT MOTION TO STAY INITIAL BRIEFS FOR 60 DAYS TO ALLOW  
PUBLIC BODIES TO CONSIDER RESOLUTION**


This appeal includes an appeal of an order on the merits by Appellant/Respondent County of Barnwell and an appeal by municipality Respondents/Appellants of a denial of attorneys' fees. The parties have been advised by Court administrative personnel that the two appeals have been consolidated under the caption shown above; and that each appellant's initial brief will be due on February 1, 2019.

All of the parties in this matter have, through certain of their elected representatives and legal counsel, been engaged in discussions for the mutually-agreeable resolution of the matters in

dispute; and they believe that those discussions have a substantial likelihood of success. Because of the time necessary for public bodies to consider a proposal (two readings by municipal councils, and three readings by County council), and in order to avoid spending public resources in litigation that may become unnecessary, each of the parties hereto moves and consents to extend the date for initial briefs by all parties by 60 days until Tuesday, April 2, 2019; and that all subsequent deadlines be measured from that date in accordance with the South Carolina Appellate Court Rules.
