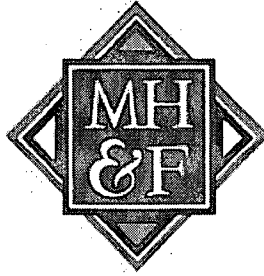

Dear Ms. Kitchings:

I'm writing to update the Court on the status of this matter pursuant to the December 19, 2018 order. By way of background, Appellant simultaneously filed a notice of appeal and a petition for supersedeas to stay the execution of judgment following a bench trial, while a motion to stay was pending before the trial court, in order to comply with the South Carolina Appellate Court Rules. This Court held the matter in abeyance pending a ruling from the trial court and requested an update within thirty days. As it stands, the trial court has not ruled on the motion to stay.

Additionally, as a small housekeeping matter, the case caption is incorrect. Since this case was before the Court in 2013 the parties were re-aligned and the caption should be *Andrews v. Broom*.


