MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF

Counsel for Bill Breeland respectfully requests a **final thirty (30) day extension, until February 18, 2019**, in which to file the petition for writ of certiorari and appendix in this case.



4. Counsel makes this request in good faith and not for purpose of delay.


5. Counsel for the Attorney General's office consents to this request as shown by signature below.


