
MOTION

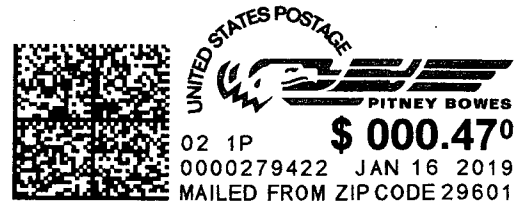
