I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

that on 03/03/2017 the defendant, Robert Richardson Jr., did commit the offense of P.W.I.D. COCAINE WITHIN 1/2 MILE PARK, in violation of 44-53-445(A). Specifically Agents with the 15th Circuit DEU were assisting Officer Nesmith with the Andrews Police Department serve an arrest warrant on Robert Richardson Jr. at his residence at 808 Martin Luther King Jr. Dr. in Andrews South Carolina. Subsequent to the arrest Agents smelled a strong odor or raw marijuana coming from the house. During a consent search of the residence approximately 2.8 grams of white powder substance, packaging materials and digital scales were recovered. The substance field tested positive for Cocaine. The offense occurred in the County of Georgetown and within 1/2 mile of the county park located at the corner of M.L.K.
