
PETITION FOR REHEARING

Pursuant to South Carolina Appellate Court Rules 221 and 240, the Appellant South Carolina Workers' Compensation Uninsured Employers' Fund (Fund) moves this Court for a rehearing of its Order filed January 3, 2019. This request for rehearing is based on points which the Appellant/Respondent believes the Court overlooked and/or misapprehended as set forth in the Petition for Rehearing and Memorandum of Law filed by Appellant Esteban Vera Reyes d/b/a Esteban Construction (dated January 10, 2019) and in the Petition for Rehearing filed by Appellant Gerald Builders of Conway, Inc. (dated January 9, 2019).

The facts of the Fund's appeal and its dismissal by this Court and the South Carolina Workers' Compensation Commission are identical to those appeals of both other appellants. The Fund hereby adopts the arguments set forth the Petition for Rehearing filed by the other appellants




