Dear Ms. Kitchings:

I am writing to notify the Court of an error with the timestamp on a recent filing in the above referenced case. On Thursday, December 27, 2018, I hand delivered Appellant's Initial Reply Brief and Proof of Service to the Court of Appeals for filing. Immediately thereafter, I served a copy of the same upon counsel for Respondent via U.S. Mail. However, while reviewing my calendar this past Friday, I noticed that the clocked copy of the brief in my files bears a timestamp reflecting December 21, 2018—six days prior to the filing date. This timestamp appears to be in error, however I do not believe this will affect any deadlines in this case.

I have reviewed Rule 210(a), SCACR, which provides that Proof of Service of the Record on Appeal shall be filed "[w]ithin thirty (30) days after *service* of the last brief. . . ." By my understanding of that Rule, because the last brief was served upon Respondent's counsel on December 27, 2018, the Record is due to be served upon Respondent by Monday, January 28, 2019. Please notify me if I have calculated this deadline incorrectly.

Thank you very much for your attention to this matter.


