Personally appeared before me the affiant E Calendine who being duly sworn deposes and says that defendant Sharkee Alejandro Mitchell did within this county and state on 06/27/2017 violate the criminal laws of the State of South Carolina (or ordinance of County/ Municipality of Hilton Head Island) in the following particulars:

DESCRIPTION OF OFFENSE: Pointing and Presenting Firearms at a Person

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on or about June 27, 2017, the Defendant, Sharkee Alejandro Mitchell, did willfully and unlawfully commit the offense of Pointing a Firearm at Another Person. The defendant used a silver and black revolver to threaten the victim Beverly Ladson Heyward. The victim confronted the defendant about using marijuana in her residence. The defendant physically assaulted the victim by striking her in the face with an open hand multiple time. The victim observed the defendant point the silver and black revolver at her face, while he threatened to kill her.
