


It appears to the Court that the captioned matter has been resolved by way of settlement of all issues including the issue on appeal.

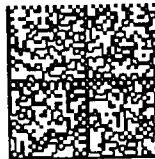
