Respondents' Motion to Correct/Supplement Record

Respondent Keith Jayma ("Jayma") moves for an order permitting Respondent to Correct and/or Supplement the Record on Appeal to include the following matters that were designated by Respondent, but not included in the Record or Supplemental Record on Appeal filed by Appellant:


1. Affidavit of Keith Jayma including all exhibits – Mr. Jayma's affidavit appears at pages 176-178 of the Record, but Exhibits A-E to that affidavit were omitted from the Record.
2. Exhibit 9 to Wilson dep. – Exhibit 9 to Appellant's deposition was omitted from the Record.

Respondent also moves for an order permitting Respondent to supplement the record to include Respondent's Answer, filed August 13, 2012. In Respondent's Designation of Matter, Respondent's Counsel designated Respondent's answer for inclusion in the record, but

mistakenly identified that pleading as one “filed on May 11, 2012.” In fact, the Answer filed on May 11, 2012 was filed by another defendant, and not by Respondent. Respondent’s answer was filed on August 13, 2012. As a result of Counsel’s mistake, Respondent’s answer was not included in the Record on Appeal. Respondent requests leave to supplement the Record, so that Respondent’s filed answer is included in the Record. Respondent also requests that the time to file Final Briefs be extended until the Record has been corrected and/or supplemented.

Counsel certifies that each of these documents was designated for inclusion in the Record by Respondent, and further certifies that each of these omitted documents is relevant to this court’s consideration of this appeal.


