

**MOTION FOR EXTENSION OF TIME TO FILE RETURN TO PETITION
FOR REHEARING**

Pursuant to Rules 221 and Rule 240 of the South Carolina Appellate Court Rules, the undersigned, as attorneys for the Respondent, Kohler Company, hereby moves for a ten (10) day extension of time to file and serve a Return to the Petition for Rehearing filed in this matter on January 22, 2019. 
