Enclosed please find the "proof of service" showing that the notice of appeal was served upon the opposing party on 1/16/2019.


In addition, by my signature below, "I certify under penalty of perjury, 28 U.S.C. §1746, that the June 18, 2018 dismissal of my PCR was just received at the Leiber Correctional mailroom was not received by the appellant until January 14, 2019. At this time I initiated my appeal rights."

Moreover, for the record, I have not been recently transferred to this institution, but was here at all pertinent times involving the time I should have received the final decision.

As for item (3), requesting an explanation as to why the notice of appeal should not be dismissed. Appellant refers to the record where this Court is aware "it was counsel's duty under Martinez v. 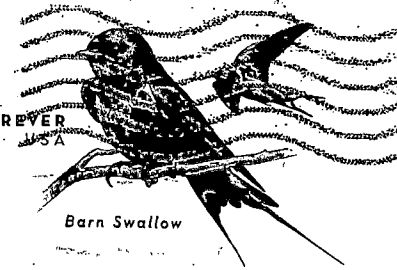
