
**NOTICE OF APPEARANCE**

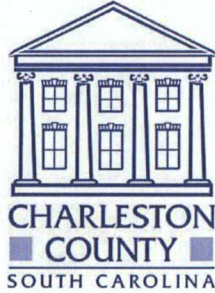

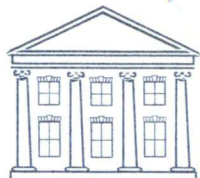
