



Dear Bobby, Linda, and Sheila:

Just to clarify, we have to let the court know that we are appealing the case on or about August 18th, which is thirty days (30) from when the consent order was filed.

Also, the cost of the appeal will be as follows: We have to request a copy of the Trial Transcript, which will cost around \$6,500.00, as well as submit a brief which will cost around \$15,000.00 in legal fees. Another cost will be the Bond hearing which the Judge could set as low as \$24,000.00. We will need you to pay all of these costs in advance.

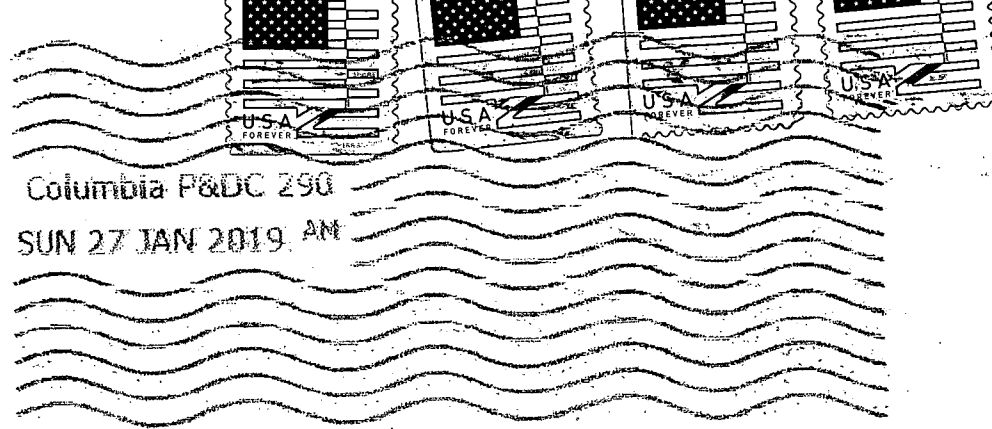
